ADDITION OF A RMB COUNTER

Reference is made to the announcement dated 21 April 2023 of China Mobile Limited (the “**Company**”) in relation to the Company’s application to add a Renminbi (RMB) counter for the trading of shares in the Company listed on the Main Board of The Stock Exchange of Hong Kong Limited (the “**Hong Kong Stock Exchange**” and such shares, the “**Hong Kong Shares**”).

The Board of Directors of the Company (the “**Board**”) is pleased to announce that the addition of a RMB counter for the trading of Hong Kong Shares of the Company on the Hong Kong Stock Exchange (the “**RMB Counter**”) will be effective on 19 June 2023, under stock code 80941 with stock short names “CHINA MOBILE-R” (English) and “中國移動-R” (Chinese). Hong Kong Shares will be denominated in RMB and traded in board lots of 500 shares each on the RMB Counter.

There are no changes to the existing arrangements with respect to the trading of Hong Kong Shares of the Company on the HKD counter on the Hong Kong Stock Exchange, under stock code 941 with stock short names “CHINA MOBILE” (English) and “中國移動” (Chinese) (the “**HKD Counter**”). Hong Kong Shares will continue to be denominated in HKD and traded in board lots of 500 shares each on the HKD Counter.
